Over the years the UCCI Excellence Awards have been established as highly coveted honour among the industry fraternity and some of the best enterprises in Southern Rajasthan have received the awards for their achievements. Udaipur Chamber of Commerce & Industry has been conferring the Excellence Awards to Industries for last 4 years in the following 9 categories-

*There are only 3 categories for Small, Medium and Large enterprises in Services Sector Awards. CSR and Social Enterprises categories are open for companies of all sizes.

Eligibility Criteria – Manufacturing Sector Awards:

1. Awards would be given to a firm or company and not to an individual.
2. Any firm or company with an investment in plant and machinery **above Rs.25 Lakhs**, and which has Manufacturing Unit located in any of the following districts of Rajasthan: Udaipur, Sirohi, Dungarpur, Banswara, Chittorgarh, Rajsamand, Bhilwara and Pratapgarh will be eligible for the awards.
3. Any firm or company that has its registered office outside Rajasthan can apply provided the manufacturing unit is in Rajasthan in any of the above-specified districts of Rajasthan.
4. Any mining firm/company independently will not qualify for the awards, but if it has a manufacturing unit also, i.e. mineral or stone processing unit, it will be entitled to apply.

Eligibility Criteria – Services Sector Awards:

1. Awards would be given to a firm or company and not to an individual.

2. Any firm or company delivering services to individuals or industry and that is located in any of the following districts of Rajasthan: Udaipur, Sirohi, Dungarpur, Banswara, Chittorgarh, Rajsamand, Bhilwara and Pratapgarh will be eligible for the awards.
3. Any firm or company that has its registered office outside Rajasthan can apply provided the unit delivering the service is in Rajasthan in any of the above-specified districts of Rajasthan.

Eligibility Criteria – Social Enterprises:

1. An enterprise whose primary objective is to produce and sell products, services and / or business processes that address social needs or problems while generating revenue from these business activities is a secondary goal will be eligible for the awards.
2. The award will be given to a firm or company and not to an individual.
3. Any firm or company which has business operations located in any of the following districts of Rajasthan: Udaipur, Sirohi, Dungarpur, Banswara, Chittorgarh, Rajsamand, Bhilwara and Pratapgarh will be eligible for the award.
4. Any firm/company that has its registered office outside Rajasthan can apply provided the manufacturing unit is in Rajasthan in any of the above-specified districts of Rajasthan.

Eligibility Criteria – CSR :

1. Awards would be given to a firm or company and not to an individual.
2. Any firm or company that has its registered office outside Rajasthan can apply provided the manufacturing unit is in Rajasthan in any of the above-specified districts of Rajasthan.
3. Any firm or company delivering services to individuals or industry or in the manufacturing and mineral processing sector and that is located in any of the following districts of Rajasthan: Udaipur, Sirohi, Dungarpur, Banswara, Chittorgarh, Rajsamand, Bhilwara and Pratapgarh will be eligible for the awards.
4. Any firm or company that has its registered office outside Rajasthan can apply provided the unit delivering the service is in Rajasthan in any of the above-specified districts of Rajasthan.
